PREREGISTRATION: I understand that there is a Non-Refundable \$200.00 deposit (\$250 for non-current members) to reserve a spot in Kids' Club. Please note that this only applies to those who sign up before August 2018. The deposit will go towards the first month tuition.

REGISTRATION: One registration form per family is required. Registration may be done in the office, by mail, or fax. Payment for the first month's tuition and the annual membership/insurance fee are due at the time of registration. We accept VISA, MasterCard and American Express.

THE ANNUAL INSURANCE/MEMBERSHIP FEE IS NON-REFUNDABLE

BILLING/DISCOUNTS: Billing is emailed on the 15th of each month. Tuition received after the 10th of the current month due, is subject to a \$10 late fee. Tuition is required even if your bill does not reach you. Children will not be allowed to participate in class after the 15th of the month if an account is past due. They will be allowed to resume class when the account is brought up to date. We do offer automatic payment by credit card. The automatic payment is drafted on the first of the month or it can be drafted from your credit card on the 15th of each month for the following month (a \$5 discount is given per account). The automatic discount does not apply to pro-rated or promotional months. A \$15 fee will be added to all returned checks.

ABSENCES: In the event that your child is absent, parents must notify the Kids' Club manager by 11:00 AM. In the event that you fail to notify the manager of your change in schedule, a \$15 fee will be charged to your account for the first time, \$20 the second time, \$25 the third time and \$30 anytime after.

SCHEDULE CHANGES: For any kind of schedule changes, you must give a written 30-day notice.

DROPPING KIDS' CLUB: If you wish to drop out of our program, you must give us a written 30-day notice. If a drop notice is not received, your child will remain enrolled.

PARENT PICK UP: Children need to be picked up no later than 6:30 pm. After 6:30 pm, you will be charged a \$5 fee for every five minutes you are late. If an emergency should arise that would prevent you or an authorized adult from picking up your child on time, please notify the Kids' Club Manager.

HOLIDAYS: Kids' Club will be closed on all Federal holidays, but will be open on early dismissal days & school holidays. Kids' Club may be able to pick up your children on special Minimum Days. Parents may drop off children attending Kids' Club on non-school days anytime after 2:30pm. You must notify the Kids' Club Manager of any planned absences.
