Vacation Friendly FAQs

Q What if my child cannot attend a minimum of six weeks?

A You must pay for at least six weeks to keep your child's spot in a class. If your child cannot attend six weeks, please schedule makeup classes per our makeup policy, or email a 30-day notice to twistersfun@hotmail.com.

Q I have multiple students enrolled and they will be gone on different dates. How can we plan accordingly?

A The vacation credits are applied per child. You may select up to 6 weeks for each individual student with different dates.

Q I already submitted a Vacation Friendly form, but our summer plans have changed! Can we update our scheduled attendance?

A Yes. Please email your revised schedule and we will update our roll sheets/billing accordingly.

Q My child has accrued makeup classes that they have not done. Are we able to makeup them up during the summer?

A Yes, makeup classes may be done anytime a student is still enrolled with Twisters (within the makeup policy). Please contact the front desk if you would like to attend a makeup class during a scheduled vacation week.

Q Do classes continue at the end of summer?

A Yes! Classes are ongoing, and your child will remain enrolled at the end of summer unless you submit a 30-day notice to take a break.

Q We would like to take a break and are not sure if we will return in the fall. How do we stop billing?

A The Vacation Friendly option is only for students who remain enrolled in classes during the summer. If you would like to take a break,

Please email a 30-day notice. Please note that any remaining vacation credits will not apply if you discontinue enrollment.

Please note vacation credit is applied to your account and does not always correlate to the vacation weeks (For example, if you will be gone the June 16th week, the credit may be applied towards the ☐August☐billing cycle.) Rest assured, if you are using ☐X☐number of vacation weeks, your account will receive ☐X☐number of vacation credits.
